With reference to the subject cited above and aforesaid letter, this is to bring to your notice that under-mentioned colleges situated in the jurisdiction of this University have approached to this University with request to convey the status of affiliation of the colleges for M.Ed. course to your cell for the session 2025-26. In this connection, it is stated that the below mentioned colleges are still under consideration for granting extension in provisional affiliation by the University for the session 2025-26, the process for which will be completed very soon.

(A) The Colleges applied for Extension in Provisional Affiliation:-

In this regard, I am directed to inform you that this University has no objection for allotment of students to the aforesaid colleges subject to the fulfillment of the following terms and conditions of the state Govt./NCTE and University Rules & Regulations: -

- समस्त प्रवेश केन्द्रीकृत व्यवस्था के अन्तर्गत कोटा विश्वविद्यालय, कोटा के माध्यम से प्री-एम.एड. 2025 परीक्षा में सम्मिलित छात्रों में से मेरिट के आधार पर प्रवेश दिये जायेंगे।
- महाविद्यालय राज्य सरकार द्वारा निर्धारित शिक्षण शुल्क के अतिरिक्त किसी भी प्रकार की कोई राशि छात्रों से नहीं ली जावेगी। यदि इस संबंध में किसी प्रकार की शिकायत प्राप्त होती है तो संबंधित महाविद्यालय की सम्बद्धता को तुरन्त प्रभाव से समाप्त कर दिया जायेगा।

3. महाविद्यालय को एनसीटीई एवं राज्य सरकार द्वारा निर्धारित सभी मापदण्डों की पूर्ति करना अत्यावश्यक होगा।
4. महाविद्यालयों द्वारा उपयुक्त योग्यताधारी शिक्षकों की उपलब्धता की सुनिश्चितता की जावेगी।
5. सूची में अंकित महाविद्यालयों द्वारा संस्था सचिव द्वारा एनसीटीई के मान्यता पत्र के विन्दु संख्या 06 की पूर्ण पालना करने के पश्चात् ही विश्वविद्यालय द्वारा सम्बद्धता पत्र जारी किया जाना संभव होगा।

As per University Rules and Regulations, the college will have to follow the following terms & conditions.

1. These colleges will have to complete all the requirement/formalities for running M.Ed. colleges as per the norms laid down by the NCTE, UGC, State Government and University Affiliation rules.
2. Qualified Principal and faculty are to be appointed as per NCTE norms and University rules.
3. These Colleges should have Library, Laboratories, Computer Lab and other infrastructure requirement as per the NCTE and University norms.
4. The University inspection committee will inspect/re-inspect the college and if the proper requirements are not found, the above permission shall be treated as withdrawn.
5. This NOC is purely provisional and subject to the fulfillment of all the conditions laid down by the NCTE, State Government and University Affiliation rules.
6. The University has legal rights to withdraw affiliation of the college any time, if the conditions are not found satisfactory.
7. These colleges if not found proper will have to go through re-inspection and the re-inspection fee will to be deposited by the concerned colleges within a month to complete the deficiencies pointed out to them.
8. All the requirements will have to be completed within two months' time.

If the infrastructure and Faculty in the college are not found proper in accordance with the affiliation rules/NCTE norms/State Govt. norms, during the course of inspection, the college shall be subject to dis-affiliation and the students of such college shall be transferred to some other colleges.
